An entrance fee of \$20 must accompany this application. If the application is faxed or emailed, the entrance fee must be paid on Friday, February 26 2009 at the contestants' meeting at 7:00pm, or can be mailed to Club XS at the address above. This entry fee will be placed in the Travel Fund for the 2010 title holder.

Club XS reserves the right to limit the number of contestant registrations.

CONTESTANT REQUIREMENTS:

The contest is a gay male event. Contestants must be:

- 21 years of age
- legal resident of The United States
- male
- self-identified as gay

Contestants must attend a "Meet & Greet" at Club XS on Friday February 26, 2010 from 7:00 pm to 10:00pm. A brief contestants meeting will be held from 7:00 pm to 7:30 pm. Contestants are encouraged to use the Meet & Greet time to get acquainted with the other contestants, judges and Club XS personnel/producers. While the Meet & Greet time is not necessarily judged, contestants should conduct themselves with the full knowledge that they will be making an impression upon the judges.

All contestants are required to arrive at Club XS at Noon on Saturday, February 27, 2010 to

check in for the contest. Numbers indicating the order of interviews will be randomly drawn at check in. Contestant interviews will begin **promptly** at 1:00 pm. Once you have completed your interview, you are free to leave. Your attire is your choice, but “leather casual” is suggested. Lunch will be provided.

All contestants must report to Club XS for the contest no later than 6:00 pm. Dinner will not be provided. The contest will start **PROMPTLY** at 8:00 pm. NO EXCEPTIONS. All contestants should plan accordingly.

Each contestant will be permitted ONE assistant/dresser backstage during the contest.

Genitalia may not be exposed at anytime on stage or in public areas of the club.

Special pricing arrangements with local hotels are usually available. Contact Charles Oswald at Club XS for more information if you will need a hotel room(s).

Each contestant will be required to show proper legal identification and to sign a photographic release and waiver upon checking in for the contest Friday February 26th at 7:00 pm.

FRATERNIZATION WITH JUDGES:

Contestants are encouraged to socialize publicly with the judges. However, private meetings between judges and contestants are strictly prohibited during the weekend of the contest. Any appearance of impropriety or potential for bias will be brought the attention of the judges panel who will vote to decide if the contestant and/or judge will be disqualified.

JUDGING CATEGORIES:

Interview: 80 points

Each contestant will meet privately with the panel of judges and respond appropriately to whatever questions are asked. The interview portion will last approximately 10 minutes for each contestant at the discretion of the judges.

Bar Wear & Introduction 40 points

Each contestant will appear onstage wearing the bar wear of his choice and will be introduced by the MC. Judges will be assessing confidence, attitude and presence.

Jock Strap and Question – 40 points

Each contestant will appear on stage in the jock strap or skin wear of their choice and will be asked to respond to a question randomly drawn by the contestant while on stage. They will be allowed 30 seconds to read and consider the question and 90 seconds to respond.

Formal Leather & Speech 40 points

Each contestant will appear onstage wearing their choice of formal leatherwear. Included in this portion each contestant will deliver a speech of up to 2 minutes. Each speech should be delivered on the topic of “*Should you win Mr. Club XS Leather, how would you use your title to improve the community?*”

EXPECTATIONS OF MR. CLUB XS LEATHER:

Mr. Club XS Leather is expected to be part of any Club XS participation in a local Pride event.

Mr. Club XS Leather is required to attend one of the two monthly leather events at Club XS each month. With their attendance is included a free bar tab for himself.

At his option, Mr. Club XS Leather will compete at International Mr. leather in Chicago over Memorial Day Weekend 2009 and will also be required to have applied for his passport prior to the competition in case he wins.

Mr. Club XS Leather is responsible to hold at least one major fundraiser for the charity of his choice during his title year and is also allowed to conduct smaller fundraisers at Club XS leather events, should they choose to do so, to help raise money for the travel fund. (The travel fund will be controlled by Club XS and distributed accordingly.) All fundraising effort must receive the prior approval of Club XS Management.

Mr. Club XS Leather will return to the Mr. Club XS Leather 2011 competition as a judge and to pass on his title.

Ideally, Mr. Club XS Leather will be a regular presence at Club XS and will represent Club XS at other regional Leather events, clubs and bars.
